### SECTION 2: HAZARD IDENTIFICATION

#### EMERGENCY OVERVIEW

CAUTION: This product is a clear to pale yellow or clear blue liquid with a pleasant odor. Direct contact with eyes may cause irritation, with possibility of corneal injury if not removed promptly. It may be harmful if swallowed. Repeated or prolonged excessive exposure with skin can result in defatting and drying which may result in irritation and dermatitis. Keep out of reach of children. No significant environmental effects. Not a fire hazard. Product is stable.

## SECTION 4: FIRST AID MEASURES

---

**EYES:** Immediately rinse eyes with plenty of water for at least 15 minutes, occasionally lifting upper and lower lids, until no evidence of product remains. Get medical attention if pain or irritation persists.
